6th ANNUAL PRINCESS/QUEEN DIAMOND TOUR ENTRY FORM

2020 Princess/Queen Diamond Tournament Rules

1. **Eligibility:** This is a scratch tournament and is open to women who are USBC Sanctioned. Multiple entries are allowed in the same division.
2. **Entering averages :** All averages will be verified by the tournament director via bowl.com. 4D Entertainment uses the bowler's highest composite average over the past two seasons (2017-18 & 2018-19). This is NOT negotiable. Any bowler without a verifiable yearbook average, MUST bowl in the Princess I division as a 200 average bowler.
3. **Early Entry Fee: Queen and Princess I Division - \$65.00. Princess II and III Divisions –\$50. All prize fees will be returned 100%** in each division at 1:6 ratio. **Entries postmarked after Sep 4, 2020 - Entry Fee: Queen & Princess I-\$80.00 • Princess II & III-\$65.00.**
4. **Personal checks** will not be accepted after **Sep 4, 2020**. If a check is returned for NSF, the entry will be voided and there will be a \$30 NSF fee from 4D Entertainment.
5. **Format :** On day 1 of the tournament there are two or three squads, depending on the location we are bowling at. Multiple entries are allowed. All early bird entrants will receive the early bird entry fee for all qualifying squads per stop. Seniors will ALWAYS be early birds, regardless of division or average. The highest qualifying score will be used for each entrant to make the cut in their divisions. No entrant may compete in more than one division during any given tournament weekend. Each lady will bowl 4 games, moving one pair of lanes to the right after each game. At the end of all Day 1 squads, each division will be cut to the top 50%, rounding up for an odd number of entries in each division. The top 50% will be invited back for Day 2.
6. The semi-final round starts on Sunday morning. Each lady will bowl three games each, on the same pair of lanes, which will then be added to the previous four games from day 1 for a seven game series total. The top 5 series from each division will then go to the seeded finals match play round. Match play will be #5 vs #4, one game with the highest game moving forward to play #3, until a winner has been determined. Each division will be paid according to entries.
7. Any bowler arriving after play has started will be allowed to bowl, but must start in the frame being bowled at the time they enter the game. Bowler will receive "0" for all frames missed.
8. Bowlers are required to report no later than one-half hour prior to scheduled squads starting time. Collared shirts or mock collars MUST be worn to participate. If an entrant does not have on a collared or mock collared shirt, a \$10 fine will be imposed and applied to the general prize fund. No food or beverages will be permitted in the bowling pit.
9. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or there from, fire, natural disaster or any other reason beyond the control of the Princess/Queen Tournament shall cause, to the extent required thereby, all advertised prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
10. **This is a USBC Certified Tournament.** Any rules not covered herein shall be decided by the tournament committee. All decisions of the tournament committee are final unless an appeal is made in accordance with **USBC Rule 329**.
